PAYMENT PLAN: (Class Program Tuition plus Day Care Fees)

THE ENTIRE TUITION AND DAY CARE FEES MAY BE PAID WITH APPLICATION, DUE MONDAY, MARCH 30, 2020 OR:

- 1/3 of total due with application (no later than Monday, March 30, 2020)
1/3 of total due by June 1, 2020 (to appear on the June 2020 statement)
Balance of account due by July 1, 2020 (to appear on July 2020 statement)

## TERMS AND CONDITIONS

**ENROLLMENT:** All account balances must be current before your child or children may attend the 2020 SUMMER MINI-CAMP program.

**PAYMENT OF TUITION AND DAY CARE PROGRAM FEES:** 1/3 of all charges are due with application. The balance is due in two equal payments; June 1, 2020 and July 1, 2020. A statement will be mailed on or before the 20<sup>th</sup> of each month, due and payable on the 1<sup>st</sup> of each month and subject to a \$25.00 fee if not received by the 5<sup>th</sup> of the month.

*For those attending the Summer Mini-Camp program only and not enrolled in the regular school year, full payment is required at time of enrollment. The monthly payment plan is not available.* The rates and fees set forth on the front side of this agreement are not subject to change during Summer Mini-Camp.

**The entire tuition and day care fees may be paid with the application/agreement.**

**OVERTIME DAY CARE CHARGES:** Hourly charges for children arriving before or departing after their scheduled session time will appear on the monthly statement at the rate of \$10.00 per/hour or a part there-of. There is a 10 minute grace period allowed before overtime charges are incurred. If your child is not picked up by 6:15 p.m. a charge of \$10.00 per/10 minutes or a part there-of will be incurred. The 10 minute grace period does **not** apply in this situation. (No Proration)

**RETURNED CHECKS:** Checks returned from the bank are subject to a \$35.00 service charge.

**ABSENCE:** No reduction in tuition or day care fees will be made for a child's absence, illness, late arrival or any acts of God or war, declared or undeclared, which preclude a child's attendance.

**CHANGES AND WITHDRAWALS:** Any changes to the program selected must be submitted in writing. Withdrawals from the SUMMER MINI-CAMP must be submitted in writing at least 4 weeks prior to the withdrawal date. Installments will not be refunded without notice.

**TERMINATION OF ENROLLMENT:** The undersigned parents or legal guardian agree that failure to pay charges when due may necessitate the termination of enrollment of their child in the SUMMER MINI-CAMP program. Such termination will not relieve the undersigned from the Terms and Conditions stated herein.

**INSPECTION:** The Department of Social Services, Community Care Licensing Division (CCR, Title22, Section 101200) has the inspection authority for this facility as specified in the Health and Safety Code sections 1596.852, 1596.853, 1596.8535.

**ATTORNEY FEES:** In the event of a commencement of a suit to enforce payment of this agreement, the undersigned parents or legal guardian agree to pay any additional sum as attorney fees or collection fees as the court may adjudge reasonable.

**AGREEMENT BINDING:** This agreement binds each of the undersigned, if more than one, jointly and severally.
